



## A New Relationship Brought My Old Issues Back



I am an incest survivor; I met an alcoholic the day I was born. I replaced him with other alcoholics, as well as gamblers and addicts of every kind. I was single until I was 52. I remember thinking, "I've finally got myself a 'normal' guy!" But the truth was, his life had been affected by someone else's drinking and he hadn't yet found recovery. I received one key piece of wisdom when I agonized over whether to marry this man I loved: a Sponsor told me not to place all my eggs in my fiancé's recovery. Ask the question: "Do I trust my own tools; my own recovery?" and I did. And I do. I had 12 hard-fought years in Al-Anon, working the Steps over and over, reading, sponsoring and being sponsored, and participating in service work. But when I got into this relationship, it wasn't enough. I had to be a newcomer again – a frightened, angry newcomer. I've heard that being in a relationship is like pouring fertilizer on all my character defects. I have lived with fear and anger all my life. I still do, to some extent. But I'm crawling out of it. And it hasn't been only crawling. There has been a lot of dancing in these years of recovery. My partner's got more than three years in Al-Anon today. He's growing, I'm growing, and it's good. I talk to my Sponsor. It is so important to me to be accountable and to tell the truth to someone. A Sponsor is essential for me because I tend to keep secrets – and secrets are deadly to me. When I did my last fourth Step, I looked hard at my life; I talked about all the embarrassing stuff – and the shame is *gone*. Shame drags me down and makes me ill. I try to be very careful to tell my Sponsor all the dirt. My Sponsor knows it all and loves me anyway. I pray and meditate. I can't sit still so I do a nine-minute meditation each morning: three minutes of writing; three minutes of silence; and three minutes of reporting. It is good, and my Higher Power has often spoken to me in the silence. I can recover for fun and for free. All I need to do is give back to the newcomers coming in the door with fear and anger in their eyes what was given so freely to me. **Reprinted with permission of The Forum, Al-Anon Family Group Hdqts., Inc., Virginia Beach, VA**

**Dominance, Promotion, and Loving Interchange.** In the Optional Readings section of our Service Manual, we find the "Three Obstacles to Success in Al-Anon" which was taken from the pamphlet: Alcoholism, the Family Disease (P-4). One of the obstacles is Dominance and we are reminded that no member of Al-Anon should direct, assume authority, or give advice. Offering personal advice or giving the impression that we are the experts who know what is best for all friends and families of alcoholics is a form of promoting Al-Anon and is contradictory to Tradition 11. Loving interchange isn't restricted to what is said during meetings. It can happen before and after group meetings, while talking on the phone with another member, and at one of the many Al-Anon events taking place in our District, Area and beyond. One of the benefits of attending Al-Anon meetings is learning how to communicate with others in a healthy way. Everyone shares as an equal, keeping the focus on Al-Anon and our own recovery. On occasion we may attend a meeting that seems to be dominated by two people, one giving advice to the other, and the message communicated is different from what we receive at a meeting where members share their own experience, strength and hope and then allow others to do the same. Maintaining loving interchange without interrupting or giving advice is an invitation to every Al-Anon member in learning to practice recovery principles in every situation and circumstance.



**Record Sales for AFA.** Participation in the 2017 *Al-Anon Faces Alcoholism (AFA)* public outreach magazine project resulted in record-breaking sales!! Al-Anon members ordered a total of 184,675 copies of the magazines for the second printing, which exceeds the previous record achieved in 2012. WSO is grateful for the additional efforts members and Al-Anon service arms are making to reach more families and friends of alcoholics with our message of help and hope with AFA magazines. This is a public outreach success worthy of celebration!!! Together We Can Do It.

**Taking a Group Inventory.** I recently had the privilege of participating in a meeting dedicated to taking a group inventory. Each member was given a copy of the Al-Anon guidelines the previous week and encouraged to answer the questions in each section according to their own experience with the group, the meeting, and their own part as a member of the group. One topic discussed at length was whether the group has a process for handling problems. We also discussed encouraging members to volunteer for leading a meeting, as well as rotation of other leadership roles within the group. Many ideas were shared during the meeting and everyone was given an opportunity to speak. As a result of the inventory meeting, motions were made, the group voted and some changes were made to the format. This is Knowledge-Based Decision Making in action!!
