Public Outreach – Newsprint Offers Hope through Al-Anon

Throughout the years there have been numerous articles in print media about the disease of alcoholism and the help that can be found for family and friends. There were two articles published this year by the "Dear Abby" section of the Washington Post: On June, 24th an article regarding two sons battling each other and the disease of alcoholism; on Nov 5th a wife is "hopeless" because her husband is abusive. Although "Dear Abby" does not always suggest Al-Anon, in these two instances she did print an Al-Anon recommendaton. Meeting Idea : The General Warranties of the Conference

The spiritual foundations in the General Warranties have a central theme of prudence, which is described as a middle ground between fear and recklessness. Prudence creates a climate of harmony, effectiveness and consistent priritual progress by thinking about the future based on lessons of the past. How do each of these Warranties guard against needless errors?

- Warranty One: that only sufficient operating funds, including an ample reserve, be its prudent financial principle;
- Warranty Two: that no Conference member shall be placed in ٠ unqualified authority over other members;
- Warranty Three: that all decisions be reached by discussion, vote and, whenever possible, by unanimity;
- Warranty Four: that no Conference action ever be personally punitive or an incitement to public controversy;
- Warranty Five: that though the Conference serves Al-Anon, it shall ٠ never perform any act of government, and that, like the fellowship of Al-Anon Family Groups which it serves, it shall always remain democratic in thought and action.
